# SIGNATURE RULES

#### ARTICLE 1 INTRODUCTORY PROVISIONS

- 1.1 The OSA Signature Rules govern the rights and obligations in the signing of documents prepared by OSA, z.s.
- 1.2 The Signature Rules set out:
  - 1.2.1 The principles of signing documents, in particular documents pertaining to external relationships
  - 1.2.2 The definition of the powers of the Management Board, officers and employees in the signing of documents.

#### ARTICLE 2 GENERAL PRINCIPLES

- 2.1 The principle of a single signature affixed under the text applies to signing, with the exception of signing documents that require more than one signature.
- 2.2 Any person authorized to sign documents signs the documents in his/her own hand. The person states his/her first name, surname and job title under the signature. The job title of the signing person does not have to be thus stated in documents in which the job title is specified in the heading. The signing of documents executed in automated processes may be replaced with mechanical means. Electronic signatures of the quality required by law are used to sign documents in electronic form.
- 2.3 In the absence of the relevant manager/executive/officer, documents are signed by his/her representative. Such a representative affixes his/her signature and the "by proxy" clause to the name and job title of the manager/executive/officer.
- 2.4 Any document signed by the Management Board must be provided with the initials (signature) of the employee responsible for the relevant agenda.
- 2.5 The rules applicable to the signing of documents in documentary form shall apply mutatis mutandis for the use of electronic signatures.

## ARTICLE 3 RIGHT TO SIGN

- 3.1 Pursuant to the provisions of Article 7.1 of the Articles of Association of OSA, the Management Board is authorized to act in all matters and sign all documents of OSA documents are signed jointly by the Chairman and another member of the Management Board.
- 3.2 Under these Rules, the Management Board delegates the power to sign documents directed outside OSA to employees.
- 3.3 A list of the types of documents originating in OSA and the delegated rights to sign such documents are set out in Article 4. The rights to sign are specified according to the offices held by the employees. Senior executives are authorized to sign any documents signed by their subordinates.
- 3.4 Other specialised employees of the relevant department working in positions such as specialist, manager or lawyer have the same rights to sign as employees in the position of officer.
- 3.5 In addition to the documents specified in Article 4, each employee is authorized to sign other documents if empowered to do so by the Management Board in particular cases.



- 3.6 OSA may also act through a representative under a power of attorney issued by the Management Board.
- 3.7 In the absence of the Chairman of the Management Board or both members of the Management Board, if a document has to be signed which only the Management Board is authorized to sign under these Signature Rules, such a document may be signed by the Head of Section or individual Department which is competent to sign the document given the content thereof, provided that the following conditions are met:
  - 3.7.1 At least one member of the Management Board or the Chairman of the Management Board grants his/her consent to the signing of the document by that Head
  - 3.7.2 The absence of the Chairman of the Management Board or both members of the Management Board exceeds 7 business days
  - 3.7.3 Any delay in signing the document might cause serious damage to OSA.

## ARTICLE 4 OVERVIEW OF THE RIGHTS TO SIGN

4.1 The overview is divided according to the type of the documents signed
