



## PRICE LIST OF SERVICES

OSA – Copyright Protection Society for Music Works, z.s. (hereinafter referred to as the “OSA”) is in charge of the collective administration of copyrights. Its duty is to act with due diligence for common benefit of the authors whose rights it administers. OSA is entitled, based on the proceeds from exercising the rights or on the investment income from these proceeds, to deduct or include the reimbursement of efficiently incurred and documented costs in connection with the performance of collective administration. The reimbursement specified above is an overhead deduction, the rates of which are included in this price list. Nevertheless, some of the services provided by OSA include additional costs and/or the efficiency of activities related to service provision is uncertain. For these reasons, the provision of the services is conditioned by covering the efficiently incurred costs defined in lump sums by the following price list.
